8. Conditioned on enrollment as a full time student (12 hours credit per semester or term) at an accredited college or university in the United States.
9. Selection is made without regard to race, creed, sex or country of origin.

CRITERIA FOR THE SCHOLARSHIP CONTINUATION

1. Current Recipients need to provide proper notification by letter for continuing their education.
2. Must provide a **current official college transcript** showing a cumulative 3.0, or higher, grade point average. However, the Board wishes to retain the option to review each application on a case by case basis.
3. Conditioned on enrollment as a full time student (12 hours credit per semester or term) at an accredited college or university in the United States.
4. These scholarships are for a limit of 4 consecutive years.
5. Must be in residence (this means **Study Abroad Programs are not accepted**).
6. Student must contact the Grand Lodge Office with **any address changes**.
7. Student must contact the Grand Lodge Office if he/she transfers to another college. This information is imperative as it may affect the Scholarship.
